3. Discussion with Woburn School Committee regarding the department's FY2012 budget.
4. All financial matters pending in Committee on Finance:
  - a. Transfer \$12,000. from Property & Liability Insurance Acct. to Veterans Cash Aid Acct.
  - b. Transfer \$75,000. from BLS Ambulance Receipts Acct. to Fire/Overtime Acct.
  - c. Transfer \$15,000. from DPW Administration Acct. to DPW/Overtime Acct.
  - d. Transfer \$206,000. from various accts. To Unemployment Comp. Acct, Medicare Acct. and Short Term Interest Acct.
  - e. Transfer \$7,349. from Police Overtime Acct and Police Gasoline Acct to Cruiser Outlay Acct.
  - f. Appropriate \$30,000. from Cemetery Interest Fund to various Cemetery Accts.
  - g. Transfer \$2,500. from Auditor Salary Acct. to Library Salary Acct.
  - h. Transfer \$281,919.66 from various DPW accts. To Dix Road Sewer Station Repair Acct.
5. Public Hearing: Pursuant to Woburn Municipal Code Title 3, Article I, Section 3-3(C), the City Council of the City of Woburn shall hold a Public Hearing on the Fiscal Year 2012 City of Woburn Annual Budget.
