60 Hartwell Ave., Lexington, MA

FOR: Household Quantities Only – No Commercial Waste Allowed

FEE: Will only accept checks as payment
\$35 for up to 12 gallons of materials (dry or liquid volume equivalent)
\$60 for 12-25 gallons
* Residents bringing more than 25 gallons of materials will be charged a fee on top of the \$60 based on the amount of material.

Reminders:

1. The collection is for HOUSEHOLD hazardous wastes only. If you are a small business and need help disposing commercial hazardous waste, contact the local Board of Health.
2. Please never mix chemicals and leave chemicals in original containers if possible.
3. Woburn residents DO NOT need to pre-register with the Board of Health, just arrive at the facility on the correct dates. Please bring identification and proof of residency with you to facility. Fees to be paid at Lexington Minuteman Facility. MUST PAY BY CHECK ONLY.
4. **NO LATEX PAINT.** Dispose by drying out. Use kitty litter to absorb and dry paint. Dispose in trash bag with regular trash when dried out.

You may bring the following:

● General Household Materials

- Acids (corrosives)
- Aerosol cans (excluding empty cans)
- Art supplies
- Batteries - Alkaline batteries manufactured before 1994 and all NiCad, button, zinc and lithium batteries
- Chemistry set chemicals
- Fiberglass resins
- Furniture, floor, metal polishes and strippers
- Hobby supplies (rubber cement, airplane glue etc.)
- Mercury containing devices (switches, thermostats, fluorescent lamps, compact fluorescent bulbs (energy efficient bulbs), broken fluorescent bulbs, thermometers, blood pressure equipment)
- Moth balls/crystals
- Oil paint and paint thinners, varnish, stain and shellac (no Latex Paint is allowed)
- Paint Strippers
- Photography chemicals
- Rug and upholstery cleaners
- Solvent adhesives
- Turpentine and other paint solvents
- Wood preservatives

● Lawn and Garden Materials

- Cesspool cleaners (corrosives)
- Flammable liquids/Gasoline
- Flea and tick powders
- Fire starters
- Fungicides, Herbicides, Insecticides, Pesticides
- No-pest strips
- Poisons
- Pool chemicals
- Propane tanks, empty or partially empty, up to 20 lbs

● Automotive Products

- Antifreeze
- Batteries (autos, motorcycles, etc.)
- Brake fluid
- Carburetor cleaner
- Oil - used
- Radiator flush
- Solvents and degreasers
- Tire cleaners
- Transmission fluid
- Waste fuels (gasoline, kerosene, etc.)

● Bathroom Products

- Hair dye
- Nail polish remover
- Toilet cleaners

● Laundry Materials

- Brighteners
- Chlorine bleach
- Spot removers
- Spray starch
- Whiteners

● Kitchen Materials

- Drain cleaners
- Lighter fluids
- Oven cleaners



Please **DO NOT BRING** any of the following:

- Ammunition, Fireworks, Explosives
- Asbestos – use licensed asbestos removal contractor to dispose of asbestos
- Commercial hazardous waste
- Construction waste/building materials
- CRT's, CTU's, computer monitors, television sets etc.
- Empty aerosol cans
- Fire extinguishers - Empty fire extinguishers can be thrown away in the curbside trash. Content can be emptied by discharging it into a trash bag and then dispose of as regular trash.
- Gas cylinders (other than propane)
- Infectious or biological wastes – medical waste can be dropped off on scheduled collection days.
- Latex Paint – dry paint up by using kitty litter or paint hardener and then dispose of in regular trash.
- Medicines or syringes – medical waste can be dropped off on scheduled collection days.
- PCB's
- Radioactive materials
- Tires
- Smoke Detectors with 3-triangle recycling symbol can be disposed of in regular trash. Otherwise return to manufacturer. Smoke detectors made by First Alert and made in Aurora, IL can be sent to First Alert, Radioactive Waste Disposal, 780 McClure Road, Aurora, IL 60504-2495.

DIRECTIONS: From Rte 128S take exit 31 (Rte 4/225 heading towards Bedford). At the first light take a right, via jug handle, onto Hartwell Ave. The site is ¼ mile on the left just after the bike path at the composting facility.

If you cannot go to any of the Minuteman collections or are moving before the next one, Clean Harbors Environmental, Inc. holds HHW and electronic collections every Saturday from April 1 - October 31 at their Braintree facility.
